- 2. Install new propeller and A2295-1(P) spinner in accordance with Hartzell Manual 115() as follows:

- 3. Attach Hartzell Propeller Inc. Airplane Flight Manual Supplement HP207-2 to existing Airplane Flight Manual.
- 4. Revise weight and balance records to show the removal of the original McCauley C58, C78, C90, C401 or C404 propeller and spinner using data provided in the Airplane Flight Manual Equipment List. Enter the addition of the new propeller and spinner.

The combined weight of the Hartzell propeller and spinner is 79 pounds.
